DEFENDANT IMPERIAL BRANDS PLC'S NOTICE OF CONSTITUTIONAL QUESTION

Pursuant to Rule 5.1 of the Federal Rules of Civil Procedure and Rule 24.1 of the Local Rules for the United States District Court for the Southern District of Florida, Defendant Imperial Brands plc ("Imperial") provides this Notice of Constitutional Question.

Imperial has filed a written motion drawing into question the constitutionality of a federal statute, namely, Title III of the Cuban Liberty and Democratic Solidarity (Libertad) Act, 22 U.S.C. §§ 6081–6085 ("Title III"). The constitutional question is raised in Defendant Imperial Brands plc's Motion to Dismiss [DE 88]. The constitutional question raised is: does the Due Process Clause of the Fifth Amendment to the United States Constitution prohibit the extraterritorial application of Title III to Imperial's concededly "non-U.S." Cuban-cigar business under the circumstances alleged in the Complaint due to lack of legislative jurisdiction.
