**MSC CRUISES' NOTICE OF ADOPTION OF  
DEFENDANTS' OBJECTION TO REPORT AND RECOMMENDATION ON  
DEFENDANTS' MOTION TO STRIKE PLAINTIFF'S JURY TRIAL DEMAND**

Defendants MSC Cruises S.A., MSC Cruises (USA) Inc., and MSC Cruises SA Co. (collectively, "MSC Cruises") hereby adopt Defendants' Objection to the Magistrate Judge's report and recommendation that the Court deny Defendants' motion to strike Plaintiff's Jury Trial Demand. *See* ECF No. 350 (Defendants' Objection) and ECF No. 343 (the Report and Recommendation).<sup>1</sup>

For this reason, Defendants' objection to Magistrate Judge Louis's report and recommendation is being filed in the *Norwegian* matter on behalf of all four cruise lines.
