CLOSING OF CUBAPACK ACCOUNTS AT CREDIT MUTUEL

Flow of remittances in dollars to Cuba cancelled after pressure on a bank in Paris

The plans of the Cuban government to attract cash with the opening of new stores in dollars seem to have forgotten one detail: the determination of the Government of Donald Trump to prevent money sent by Cuban migrants from going to companies controlled by the military sector.

Three sources related to remittance transfers to Cuba in Miami told the Nuevo Herald that due to pressure from the administration and fear of U.S. sanctions, the French bank Credit Mutuel stopped providing services to Fincimex, a Cuban company related to the military sector that controls the remittance business.

As a result, transfers of remittances in dollars from the United States, which had recently begun through the agencies [Cubamax and VaCuba, are suspended](#). And the Cuban government has not found another bank that is willing to carry out these operations, the sources said.

Western Union continues to send remittances to Cuba, but the recipient does not receive them in dollars but in the local convertible currency, the CUC, devalued in the informal market after the opening of currency stores.

“Crédit Mutuel Bank closed the doors to Havanatur, Cubapack and American International Service,” used by Fincimex, said one of the sources that asked not to be identified to discuss the issue. “The intention was to have other banks take this business, but no one wants for fear of sanctions. The sad thing is that people in Cuba need dollars and family members are deprived of sending financial support to their loved ones.”

Crédit Mutuel Bank did not immediately respond to a request for comment. Following the publication of this article, a bank spokesman, Aziz Ridouan, sent the following statement:

“In 2018, upon adopting its strategic plan, Crédit Mutuel Alliance Fédérale announced its decision to focus on its banking and insurance activities in the euro zone,” the statement reads. “This has led to a gradual withdrawal of certain activities abroad, including those of Cuba. The US authorities did not intervene in this decision.”

The Department of the Treasury declined to comment. Mentioning the growing repression on the island, a senior administration official told the Herald that the goal of the U.S. current policy toward Cuba was to make it difficult for the government to conduct its international financial operations.

“We are working on new regulations that would further close all the loopholes [in the embargo] that the regime has used to manipulate the Cuban people and steal every dollar that people are trying to send to their families,” the official said. “We are closing every door, every way out.”

The fact of closing accounts at the French bank also hurts other Cuban government businesses, such as the shipment of packages from the United States through Cubapack and travel. One of the sources said that charter flight agencies feared they would not be able to pay Havanatur due to the closure of the accounts.

Cuba has no direct banking relations with the United States due to the embargo. Recently, Cuban ruler Miguel Díaz-Canel complained in a speech about the Trump administration's “aggression” and the “increase in financial persecution and freezing of Cuban bank accounts and assets in third countries.”

At the heart of the most recent crisis is Fincimex, a company that is part of Cimex, Cuba's largest commercial corporation, which in turn forms part of the largest conglomerate of Gaesa military companies.

“Currently between 45 and 50% of the remittances to Cuba arrive by informal routes. The rest is divided among approximately 20 agents who have signed contracts with Fincimex,” said Emilio Morales, president of Havana Consulting Group, a Miami-based consulting company. To receive the money, Fincimex uses a company registered in Panama, American International Service. The company issues cards that can then be used in new dollar stores. Fincimex, Cimex and Gaesa are sanctioned by the Department of State, but AIS is not.

In spite of the fact that Fincimex [was added last month to the list of restricted Cuban entities](#), the company continued to operate normally and [remittances to Cuba were not affected](#) because there are exceptions in the embargo that authorize them. But the sanction sent a message to the Cuban government that it should move the business to civilian entities, according to what several experts commented to the New Herald.

“Changes in control could satisfy Trump Administration's objectives: to reduce the role of the military within the commercial and economic infrastructure of the Republic of Cuba,” said John Kavulich, president of the U.S.-Cuba Trade and Economic Council.

However, the Cuban government kept Fincimex at the center of its plan to attract cash. In mid-July Diaz-Canel announced [an economic strategy that rested heavily on the dollars of migrants](#).

Migrants could deposit dollars in bank accounts in Cuba for their relatives, a substantial change after decades of exclusion of the Cuban community abroad. With dollars deposited in bank accounts and in AIS cards, Cubans abroad could help their relatives buy food or even support small businesses.

But the vulnerability of the plan only took a few days to emerge.

Delfina Casas applied for an AIS card at the Cubamax branch office in Homestead last week. According to what she says, she arrived there attracted by the possibility that her family would receive dollars, not CUCs.

“With the new stores, the possibility that my family could go shopping to a place where there is food is the most important thing,” she said.

After providing her mother's information in Cuba she received a confirmation email that the card was being processed and had to be delivered within seven to 21 days. “In Cuba people queue up for up to 12 hours to get cards in currencies. I thought it was a great opportunity to keep my mother from leaving the house and help her from here,” she said.

Casas was surprised when she checked the Cubamax website and saw that the option to issue new cards was canceled.

“I called and a girl told me that I couldn't send currency remittances for now, that that system was suspended and that they didn't know when I could return.”

The end of the Mules and the increase of CUBAPACK's business in US

Covid-19 crushes the 'mule' business.

TN - Mules carry bundles but not for themselves.

The COVID-19 pandemic has changed daily life in the entire planet: the dynamics of business, habits and customs of people, and a long etcetera. Within this phenomenon, in the particular case of Cuba, one of the most lucrative businesses and one that gives the population and the government the most support is the mule business. The topic of mules is not what it seems at first glance; there is a lot of hidden history behind this business.

The mule business in Cuba is dead right now. If there are no flights to Cuba there is no business, it is that simple. There are many losers in this chain of events: the Cuban government, the mules themselves, the mules' suppliers, and the people in Cuba who benefit from the mule-supplied market.

The mule business is a well-oiled and well-plotted venture created and implemented by Cuban intelligence; it is not a spontaneous phenomenon of people who venture abroad to buy merchandise and then sell it back on the island in the informal market. In reality, the latter is a facade that has been built and refined very efficiently over time.

This business arose many years ago and was created by the Cuban government out of the need to receive merchandise and money to evade the embargo imposed by the US government.

In this business, the Cuban government earns hundreds of millions of dollars annually. From fees for consular services (currently validating a passport costs 450 USD, and it must be renewed every two years), to the sale of air tickets, in addition to the airport tax and custom tariffs for entering merchandise into the country. Mules cannot travel if they do not possess a valid Cuban passport, and right there is where the money-making machinery created by Cuban intelligence begins.

This business started in the 1980s when the so-called "Cuban Community flights" began. And who traveled on those flights? Cubans who had left Cuba, especially those who had left since the 1980s, during the Mariel crisis, and later those who left as a result of the Rafter Crisis and the subsequent migratory waves that have occurred over time.

With this escape valve mechanism, the Cuban government obtained two fundamental benefits: a) they released social pressure and b) they created an expeditious route for the entry of merchandise and foreign currency into the country that gave oxygen to the dying Cuban economy.

The Mariel exodus turned out to be the escape valve used by the Cuban government in the early 1980s to eliminate discontent and the social pressure that existed on the island due to the ineffective and inefficient economic and political model created by the Castro brothers.

This operation served to seed and fertilize the mule business that would be implemented years later. First, they created a commercial and service network made up by dozens of small agencies,

mainly located in South Florida, originally to offer services for legal and immigration procedures, visa management and selling air tickets for travel to Cuba. Subsequently, the agencies expanded their business to other very lucrative items, such as shipping merchandise, sending remittances, and recharging cell phones in Cuba^[1].

Over time this business continued to grow to become a multi-million dollar enterprise that moves around \$8 billion in remittances, shipping of goods, consular services, air ticket sales, etc.

The key to this business is separating the family

The most important premise for this business is to keep the family separated for as long as possible, thus allowing the flow of money and goods for long periods of time and ensuring that the shipping cycles maintain a stable frequency. The other premise is to grow an army of migrants, thus ensuring a growth in the volume of remittances and merchandise shipments. Consequently, this has a direct growing effect on passport validation services, sales of air tickets and in fees for airport tax and custom tariffs, in addition to nurturing other lucrative businesses controlled by the Cuban government, such as car rentals and hotel accommodation, which migrants frequently patronize by inviting their relatives on the island.

Before the new Migratory Law was promulgated under Decree Law 302^[2] on October 11, 2012 and it became effective on January 14, 2013, emigrating from Cuba was very difficult. It was like undertaking a prison break like that of the legendary movie "Escape from Alcatraz". As emigration by legal means was very limited, illegal exit became the most common way of emigrating from the country.

During a very long time, Cuban emigrants were people who for some reason related to their work traveled abroad and took advantage of the trip to defect and try to reach mainly the United States, where thanks to the Cuban Adjustment Act they were allowed to legalize their immigration status quickly. Thousands of professionals who traveled on work missions emigrated under this scheme: doctors, teachers, engineers, government officials who traveled to an international conference, to receive a course or training, as well as athletes, artists, etc. People also emigrated by leaving Cuba clandestinely in rustic rafts or in boats that were managed by human traffickers. All these people who left the country illegally or defected could not return to the island in 8 years - that measure is still in force -, so thousands of families were trapped in that annoying and painful separation.

From the very moment that a Cuban decided not to return to their country, somehow, automatically, they became a mule. From then on, the challenge of their life was not only to make a living in a new country and sacrifice for their family with the hope and objective of taking their loved ones out of Cuba to reunite, but it was also supporting them financially while building the long and heartbreaking reunification route. At that moment, the emigrant became a mule that sent money and merchandise to help their family, and the Cuban government managed to increase their army of emigrants who gave oxygen to the island's dying economy. We can classify this émigré as a 'nostalgic or hostage mule'.

This explains how the migratory waves that have started in the island for over 60 years have been cyclical, with an average of 10 years between them. The migratory wave that gave rise to the mule business proper was that of the port of Mariel. During this crisis, around 125,000 Cubans left the country.

Most of the Marielitos - that's what the Cuban emigrants who left by the Mariel port were called - left their families behind. The reunification of these families took many years, even part of these migrants have still not been able to reunite.

The mid-1980s saw the beginning of the so-called "Cuban community flights" to the island. This allowed thousands of emigrants who had left via Mariel to visit Cuba. The logistics of this operation was designed by the Cuban intelligence. They first created a network of travel agencies in South Florida, primarily in Miami. That was the emergence of MARAZUL CELIMAR^[3] and HAVANATUR S.A.^[4], both companies belonging to the CIMEX Corporation^[5] that was managed at the time by the Ministry of the Interior, under the same group that coordinated a drug trafficking operation with the Pablo Escobar cartel in the 1980s, that ended in the famous Cause 1 and Cause 2 of 1989 and cost their lives to General Ochoa and Colonel Antonio de la Guardia, and a 20 year-sentence to Minister of the Interior Jose Abrantes.

All these agencies were registered in Panama and were in charge of selling air tickets, immigration procedures and other services that the travel agencies established in Miami provided to Cuban immigrants. Most of these agencies in Miami were operated by undercover agents of the government or figureheads sympathetic to the regime, who at some point also served as agents of influence in the Cuban exile community, especially with the mission of giving political support to the Cuban government in its fight against the embargo.

For emigrants traveling to the island, a network of stores was created in the country so that they could buy in foreign currency certain types of merchandise, clothing, footwear, food and other miscellaneous items for their relatives in Cuba. This is how the mule business began to grow really big. Back then in Cuba the circulation of dollars was punishable by law; so the Cuban emigrants who traveled to Cuba had to exchange their dollars for the so-called chavitos. (TN – vouchers) We can call these emigrants ‘community mules’.

The special period and the heyday of the mule business

Already by the late 1980s and early 1990s, when the socialist camp in Eastern Europe and the Soviet Union had disappeared, the Cuban economy suffered the so-called the ‘Special Period’ crisis. After losing 85% of its markets, the communist government had no other alternative than to open up to foreign investment, international tourism, and allow the circulation of dollars, self-employment and remittances to be sent in cash, among other measures, to be able to overcome the critical situation.

1994 saw the famous Rafter Crisis, which allowed several tens of thousands of Cubans to leave the country. 30,000 of them were taken to the Guantánamo Naval Base. As a result of this crisis, a negotiation ensued between the governments of Cuba and the United States, giving rise to the migratory agreements, which established that the United States would give Cuba a migration quota of at least 20,000 visas annually to emigrate to the United States.

From this, the Cuban government obtained two benefits: a constant relief of the social pressure caused by the crisis, by serving as an escape valve, and acquiring 20,000 new mules a year, who were charged \$150 individually as payment for the ‘white card’ (definitive exit permit).

In this new scenario, the mule business increased considerably. The Cuban government began to encourage Cuban migrants to travel and to this end, in 1993, when the free circulation of dollars was allowed and the sending of remittances was authorized, the CIMEX Corporation created an extensive network of foreign currency stores to set up a fully dollarized retail market. This business was aimed at Cubans who received remittances from abroad and at migrants and tourists who traveled to the island. Back then there was a boom in the emergence of dollarized store chains that spread throughout the country, such as the "Pan American Stores", the gas station networks "SERVICUPET" and "ORO NEGRO", the fast food chain "El Rapido", the store chain "PHOTOSERVICE", HAVANAUTOS S.A.[\[6\]](#) and the CUBALSE and TRD CARIBE store networks, among others.

The Cuban migrants traveled on charter flights that were managed by agencies created in South Florida, which in turn were connected to agencies set up in Panama. The latter were in charge of collecting the money from the operations in South Florida. The number of these agencies in South Florida grew up as the demand for travel increased. The number of services they offered was also expanded: it was no longer just the immigration procedures, the validation of passports and the visas; now they also included services for sending cash and merchandise. In the late 1990s and early 2000s, this network of agencies grew to over 100. By that time, they added hotel and car rental reservations to their services. Meanwhile, the migratory flow was fed each year with 20,000 new Cubans who emigrated legally and many more who did so illegally, arriving by boat, raft or crossing the Mexican border. In other words, it was a whole industry that added new mules and generated new millions of dollars by the day. We can call this new generation the 'rafter mules'

Cash remittances increased in volume year after year, as did merchandise shipments. Trips on charter flights to Cuba also augmented, as did flights on the Miami-Nassau-Havana route.

To control remittances to the island, the CIMEX Corporation had created in 1988 the Panamanian company AMERICAN INTERNATIONAL SERVICES S.A. (AIS), with number Folio N° 209034. By the year 2000 the army of mules had already grown considerably.

To get an idea of the volume that this business was taking year after year, just compare the remittances in cash in 1993 (\$242 million), to 2000 (\$986 million), 2010 (\$1.92 billion) and 2019[\[7\]](#) (\$3.716 billion). Last year, around 45% of the remittances received came through mules.

Obama and the thaw: boom and shift in the mule business dynamics

When President Obama arrived in the White House in 2009, one of the first measures he took was to free Cuban-American trips to the island, which at the time was limited to one trip every three years; and cash remittances, that were of only \$300 per semester. From then on, Cubans could travel as many times in a year as they wanted and could send up to \$10,000 a day.

In 2010 the Cuban government began a timid economic opening and allowed around 200 new modalities of self-employment. This combination of factors gave birth to a new scenario where the mule business grew considerably. Thousands of private businesses were financed and hundreds of millions of dollars in merchandise and products were moved by the mules. We can classify these as 'business mules'.

This business reached such a dimension that the number of agencies offering services to Cuban migrants exceeded 400. The merchandise now traveled not only with the mules, but it was also shipped in containers through agencies that had a contract with another Cuban company called CUBAPACK, which was and continues to be managed by the CIMEX Corporation. The demand for equipment and products for the nascent private sector grew exponentially, as successful Cuban entrepreneurs expanded their businesses throughout the country. Industrial kitchens, construction tools, furniture, power plants, refrigerators, washing machines, auto parts[8], beauty salon equipment[9], freezers, restaurant furniture, household appliances, and hundreds of other products traveled along this route of merchandise shipments by agencies. At that time, the agencies incorporated a new service: recharging cell phones[10], giving rise to the 'electronic or digital mule'.

On January 14, 2013, a new immigration law came into force. This law eliminated the infamous white card and allowed Cubans to travel abroad and be away for up to 24 months. This measure unleashed a boom of Cubans travelling abroad, and a new segment of mules emerged: 'national or entrepreneurial mules'.

This new mule segment created a remote wholesale market[11]. Thousands of Cubans began to travel abroad to buy merchandise to then sell it back on the island. Several routes were created for them, the main supply markets being: USA (Miami), Panama, Mexico (Cancun and DF), Spain, Ecuador, Russia, Haiti, Guyana, Trinidad and Tobago, and Suriname.

One of the most innovative aspects of this remote wholesale market created by Cuban entrepreneurs is its level of specialization. The people engaged in this business specialized in buying and selling different types of products that belong in different market niches. Among the products marketed by these networks of sellers, one can find anything from an electric motorcycle - which in the Cuban market sells for 2,000 USD and in Panama costs around 1,000 USD - to household appliances such as two-door refrigerators, washing machines, AC units and furniture, which are transported by sea. Miscellaneous items such as clothing, shoes, and sundries are generally transported by air in small packages of 1.5kg, which usually include 30 to 40 men and women underwear, sandals or flip flops grouped in five or six pairs, pullovers, blouses, t-shirts, baby clothes, etc.

Cuban entrepreneurs, even under the limitations imposed by the government, managed to set up a remote wholesale system that worked with the efficiency of a Swiss watch. The system achieved a much better inventory turnover level than the government-owned dollarized retail chains, as it works according to the needs of the market. Its logistics is based on a network that has such a strong capillarity that it can reach all regions of the country at a low cost and does not require storage of merchandise since it gets to the final consumer practically on request. Its source of financing is direct, derived from the sale itself and does not require bank loans or higher approvals to be executed. Its financing works on the basis of supply and demand and the profits from sales are large enough to be able to undertake again and again the magical cycle of the buy-send-receive-distribute-sell process.

This remote wholesale market that developed between the Miami-Cuba and Panama-Cuba routes is estimated to have an approximate value of between 1.5 and two billion dollars annually. The remote wholesale market created by Cuban entrepreneurs is another of the sectors where the Cuban private sector competed successfully with state companies.

In December 2014 there was a thaw between the two governments, which gave rise to the authorization of regular flights from the United States to Cuba, for which several airlines were allowed to fly to 10 destinations on the island, in addition to authorizing the trips of American tourists under 12 categories. This unleashed a tourist boom from the American market and at the same time the entrepreneurial fever on the island grew at a dizzying rate, which brought about the birth of a middle class that generated a new balance of power in the Cuban economy[12]. This new scenario showed that the mule business was getting out of control for the Cuban intelligence apparatus. It was at this time that the government brought to a halt the economic reforms undertaken on the island[13] and began to dictate new rules to stop and limit the expansion of the private sector. In the same manner, strong hurdles were erected against these new business mules, since many entrepreneurs began to export capital given that the new limitations did not allow the private sector to grow[14]. This resulted in the government starting to implement new measures to restrict the mule business, which were offering strong competition to the government-owned dollarized retail chains.

Parallel to the emergence of this new segment of national mules born in the heat of the entry into force of the new migratory law, the emigration of Cubans to the United States continued to expand, this time along new travel routes through Central America and Mexico to cross the US border. Tens of thousands of Cubans took advantage of the new migratory law to emigrate this way, which made the mule army grow even more. Even despite President Barack Obama's repealing the wet feet policy a few weeks before the end of his second term in the White House, thousands of Cubans continued and still continue to use that route to emigrate to the United States.

COVID-19 freezes the mule business

Given this reality, with Trump already in the White House, Cuban-American travel continued to increase, reaching the figure of 552,895 travelers[15] to the island in 2019. Only in passport validation, this figure represents income to the Cuban government worth \$248.8 million; with more than 50% of these travelers staying in hotels with their relatives on the island and renting cars from Cuban government agencies, which left revenues of approximately 500 million dollars to the Cuban economy. In air tickets alone, Cuban-Americans spent about \$221 million traveling to the island in 2019. That year, only for telephone recharges, digital mules left in the coffers of the Cuban state more than \$300 million. This must be added to airport taxes, which for Cuban-American travelers alone totaled \$13.9 million. In import duties on merchandise, Cuban-American travelers paid an estimate of between \$66.3 and \$82.9 million. All of these items totaled an estimate of between 1.3 and 1.3666 billion dollars. This must be added to the value in remittances and merchandise shipped. Together they totaled around \$8 billion in 2019.

By 2020 things were going to change, since early this year measures came into force limiting regular[16] and charter[17] flights to the island from the United States, which already had been limited only to Havana and in a restricted number. For this reason, a decline was expected in these revenues compared to 2019[18]. However, what no one could expect was the appearance of an invisible enemy that would turn the world economy upside down and impact heavily the Cuban economy: COVID-19.

When the COVID-19 pandemic broke leashes early this year in China, it quickly had a ripple effect in Europe and the United States, strongly impacting various sectors of the world economy, including the tourism industry. Cuba was no exception.

This brought to a halt flights to and from the island, so the mule business got completely frozen. Without flights, the business of the entrepreneurial mules drops to zero, it is that simple. Except for the hostage mules and the digital mules, the activity under the rest of the classifications has been annulled by COVID-19.

However, the activity of the hostage and the digital mules, who are in charge of sending remittances and making telephone recharges through the Internet, has also been impacted. It should be noted that many families in the Cuban diaspora in the United States have been hit by unemployment, so their financial capacity to send remittances and pay for telephone recharges has been considerably reduced.

A recent study showed^[19] that two cities in South Florida were among ten in the United States with the greatest impact in terms of unemployment as a result of COVID-19: second on the list was the city of Hialeah and fourth was Miami, which are two of the territories where most of the Cuban emigration in the United States is concentrated. It should also be noted that the unemployment rate in the United States has reached 20%, which represents a little over 36 million people without work^[20], not counting the undocumented who have lost their jobs.

On the other hand, according to statistics of flights from the United States to Cuba, in the first five months of this year, their number has declined by 51%, compared to the same period the previous year. Between April and May 2020, there were no commercial flights between the United States and Cuba, in sharp contrast to the 2,089 flights in the same period of 2019. The seven flights in April and May have been only to repatriate US and Cuban-American citizens stranded in Cuba by COVID-19. See Table 1.

The statistics are clear: the impact has been devastating. In the first five months of the year Cuba has received about 470 million less in cash remittances than in the same period of the previous year, a drop of 30.4%.

The value in merchandise sent in the months of April and May has been nil as there were practically no flights to the island. This is compounded by all agencies selling tickets, and shipping packs and remittances in South Florida being in quarantine. The only available way to

send money is Western Union. On the other hand, as there are no flights to the island, the payment of airport taxes on the island is nil, as is the income from consular procedures due to the closure of the agencies engaged in processing this service with the Cuban embassy in Washington.

Two US airlines have announced the resumption of their ticket sales for June: American Airlines and South West. However, it is still very premature to estimate whether there will be flights to the island or not, given that Cuba will keep its borders closed until June 30^[21]. Furthermore, South Florida has seen an increase in cases of COVID-19 although a gradual opening is planned for the next few days.

CONCLUSIONS

COVID-19 is having a strong impact on the mule business; it has practically reduced it to zero. The losses are counted in millions for both the Cuban government and the mules.

At a time when the mule business had become one of the main livelihoods for both the Cuban government and the population, as we have seen throughout this study, COVID-19 has suddenly frozen the dynamics of this business.

The mules' future is uncertain at the moment and this uncertainty has inflicted a deep thrust to the Cuban economy. Over the years, the Cuban government has created an army of mules at the expense of family separation and the poverty caused by their backward, medieval economy. Currently around 70% of the families on the island depend on the economic support sent by their relatives living abroad. If this business remains paralyzed any longer, the consequences could be unpredictable.

COVID-19 has put the Cuban government against the wall. Surviving at the cost of what the juicy mule business represents seems to be an option that will not be available for a rather long period of time. Therefore, the circle is closing around the ruling clique on the island, leaving as a single option on the table the total liberation of the productive forces through profound structural changes; otherwise, the total collapse of the economy is around the corner. The truth is that, if Cuba had an open and free market economy, the mules would not be mules but entrepreneurs, and the situation of the Cuban economy would be quite different.



The Gift Parcel Business to Cuba in the US

Shipments to Cuba from Miami, that small big business (I)

Juicy income on one side and the other, as from a situation that, if it changes to normality, would result in million-dollar losses

MIAMI, United States. - Leonel has a business involving the sale of electric motorcycles in Cuba. In the living room of his house, customers can choose from several models, even order the one they do not find, in a home delivery process that takes only about twenty days to be completed, a detail that could lead to the thought that Leonel is a reseller of the products carried by the so-called "mules" (smugglers) from Panama or Cancun, which is a suspicion that would be somewhat far from the truth.

Leonel is only the employee of a major business which true owner is another Cuban residing in the United States.

He receives the motorcycles he sells, beyond the economic embargo, directly from Port Everglades, Florida, on a U.S. government-approved ship where other goods arrive in Havana intended for both individuals and state companies, agencies and institutions that have as intermediaries any of the companies recognized in the waiver that Barack Obama established during his presidency.

Many ignore the existence of this shipping channel to Cuba that has led to the growth of twenty small companies handling parcels to the island in U.S. territory, as well as the activity of thousands of private businesses inside and outside Cuba, in concomitance with dozens of state agencies related to health, tourism and even to the dark and unsurpassed economic system of the Revolutionary Armed Forces, as would be the case of Aerogaviota and Aerovaradero, responsible for the transfer of much of the cargo within the national territory, or of Palco, a multi-service agency belonging to the economic structure of the Council of State, although it is publicly registered as an autonomous business group.

Regulated but without limits

Complete cars and parts of these, refrigerators, washing machines, music equipment, monumental sculptures to be located in Old Havana and even high-tech medical equipment for hospitals in Cuba have been transported in recent years to ports of the island without such movement of goods attracting the attention of those who absolutely blame the "blockade" for all the economic hardships suffered by Cubans.

The official news media is not allowed to deal with the matter from any perspective. Nor is the progressive increase in shipments from Miami and the profits they generate referred to in official and public statistics. One does not even hear about a "blockade" that, in light of the advantages it entails for a few, looks more like a silk veil.

Something similar happens on the other side of the Strait of Florida, where few notice in that line of business that is increasingly active and revealing the existence of an economic duality or multiplicity that each day defines the island's political fate, while it brings juicy income from one side and the other, as from a situation that, if it suffers changes to normality, would result in million-dollar losses there and here, so the "embargo" makes the scenario of commercial adversity ideal for the prosperity of many of these agencies and their counterparties on the island.

The high volumes of cargo and the diversity of this, deposited in the Customs warehouses in Havana, have forced the construction of storage warehouses in the Mariel Development Zone, where at least one of the Florida-based companies has been authorized to operate the facilities directly and in coordination with the Cuban state-owned company Transcargo S.A.

The flow of cargo has reached levels (in which) it is no longer possible to handle the packages in the warehouses of the Port of Havana (...), thousands of containers arrive in the week from Florida and Panama (...), the technology is obsolete, the inspection, the classification, the repackaging are done manually (...), it is necessary to buy new technology and we are already witnessing the transfer of all these operations to the Mariel (ZED) with financing of the own companies established in the United States and also on the Cuban side (...), because this activity brings in hundreds of millions of dollars a year", says one official of the General Customs of the Republic.

What towards the end of the 90s and already the beginning the new millennium were just a few hundreds of containers per month sent by a couple of companies that mainly used air cargo or maritime shipping through Panama, now it threatens to collapse the receiving system in Cuba, inconveniences that many U.S. shipping companies detail in their promotions to avoid the dissatisfaction of customers to whom it is not possible to guarantee the timely arrival of their packages, and also because such punctuality seems to be a privilege of a few Cuban-American entrepreneurs who allegedly maintain “personal” agreements with the Cuban side.

“There are companies that promise to put the cargo in Cuba in one week, ten days but already within Cuba the cargo can spend up to one month or more at Customs because of the slow process (...), we know that the cargo is there, that it arrived, but the final recipient must wait to be called or for Cubapack to take the package home and that sometimes takes a week longer, a fortnight but sometimes it's been three months, six months, a year (...), due to bureaucracies, because they say that there is no electricity or lack of staff, that's why we tell customers that they are working days, that is, it does not include weekends, anyway, we do not know how, there are companies here in Miami that manage to put the package there, right at the door itself, in less than a fortnight, I do not know how they do it, if they have contacts there, I do not know,” explains the employee of one of the main and oldest companies dealing with shipping and charter flights to Cuba.

Little is allowed but you can do everything

It was in late 2009 that the U.S. government authorized the shipment of packages to Cuba, without too many restrictions in terms of value and frequency. Software, modems, memories and printers as well as other home electronics could even be included, although it was Cuba that limited the entry of telecommunication equipment on national security grounds.

The value of packages was also increased from USD 400 to USD 800 per month and these could be sent from U.S. territory to anyone within Cuba, except senior leaders, as well as state-controlled centers and institutions.

However, such facilities and exceptions, due to the impossibility to conduct a thorough investigation, have become too easy to handle by the Cuban government to avoid the embargo and provide the necessary inputs to its companies and agencies under its control, and perhaps even their personal properties, even when these businesses shipping to Cuba only have authorizations from the U.S. Department of Commerce exclusively to “conduct operations of non-commercial cargo shipment to Cuba.”

The provision, while increasing the spectrum of services to be marketed in small parcel companies operating in the United States, especially in South Florida, allowed the emergence of twenty similar new companies, the transfer to North America of some off-shore companies based in Panama and which already occupied that market of cargo transfer to Cuba from a long time ago and using third countries, as well as the creation within Cuba of almost a dozen state agencies for the transfer, reception and distribution of air and maritime cargo, a business that, according to sources of the Chamber of Commerce and the Ministry of Finance, of Cuba, consulted on it, would probably exceed 200 million

dollars per year only for the payment of basic tariff taxes and operating licenses for foreign companies approved by Cuba.

However, the directive issued by the US Department of Commerce on September 8, 2009, only came to legalize what was being done since late 2008, under the category of smuggling, especially in South Florida, even by the same companies that received approval from the Office of Foreign Assets Control of the United States Department of the Treasury (OFAC) after January 2010.

"Before 2009, cargo from U.S. ports was already being received in Cuba. (...) I mean what was not allowed, that is, refrigerators, air conditioners, parts (...), there were already agreements between shipping companies in Panama and South Florida, shipping companies operated by the Ministry of Transport of Cuba", says a former official of the Ministry of Foreign Affairs of Cuba who, for security reasons, will remain anonymous.

Senior State Department Official On Title III of the LIBERTAD Act

MODERATOR: Thank you, and good morning everyone, or good afternoon. Thank you for joining us for today's background briefing on the LIBERTAD Act, also known as the Helms-Burton Act. Today with us is [Senior State Department Official]. A reminder: Today's call is on background and will be embargoed until the end of the call. I'll now turn it over to our senior official for brief remarks and then we'll take some questions. Thank you.

SENIOR STATE DEPARTMENT OFFICIAL: Great. Thank you very much, and thanks to everyone for joining us. I know there's a lot of interest out there, and so I am pleased to discuss today Secretary Pompeo's historic determination regarding Title III of the LIBERTAD Act. As you know, the United States is committed to advancing human rights, democracy, and the rule of law in Cuba. This administration's policy towards Cuba in particular has been especially clear-eyed in its focus on improving human rights,

encouraging the rule of law, fostering free markets and free enterprise, and of course, promoting democracy and freedom in Cuba.

We, of course, are extremely concerned about ongoing human rights abuses in Cuba. The regime continues to deprive the Cuban people of fundamental freedoms, including freedom of speech, the press, and assembly. It's demonstrated over and over again that it's willing to use force to silence dissent. Reputable NGOs have reported more than a hundred political prisoners are behind bars, and most recently we saw the regime in action in the violent crackdown on opposition figures that took place prior to the February 24th so-called constitutional referendum.

Unfortunately, even under a new president in Cuba, nothing has changed. We see that the constitution retains the same authoritarian political system and simply reinforces the communist party's control over the island. Cuba continues to maintain close relations with Russia and China and has destabilized Venezuela, leading to mass flows of refugees and, of course, public health threats.

Since the LIBERTAD Act came into effect in 1996, as you are aware, every administration has fully suspended Title III. But despite that, we continue to see the Cuban state's repression of its own people, which has, in our view, persisted and even worsened. We have seen additional reputable NGOs report over 2,873 short-term arrests in 2018 and over 405 arbitrary detentions in February 2019 alone. Accordingly, this administration undertook a very serious and thorough review of Title III, the conditions on the ground in Cuba, and whether a waiver is both in the U.S. national interest as well as expedite the transition to democracy.

So based on those considerations, Secretary Pompeo has decided against fully suspending Title III at this time. So today he is announcing the suspension of Title III for 30 days. That's a period from March 19th to April 17th. But there is one crucial exception, which is that U.S. nationals will have the right to bring action against Cuban entities and Cuban sub-entities on the Cuba Restricted List. And as a reminder, the Cuba Restricted List identifies entities and sub-entities under the control of Cuban

military intelligence or security forces, which are, of course, those that are directly responsible for the repression of the Cuban people.

So finally, with this decision the U.S. is holding the Cuban regime accountable and opening a path of redress for U.S. claimants whose property was illegally and unjustly seized by the regime. We should remember that after Fidel Castro seized power, he confiscated private property of thousands of private individuals and companies without any compensation. And to date, there's really been no justice for this theft. In 1996, when Congress passed and the president signed the LIBERTAD Act, that was partially to penalize those who benefit from the rightful property of Americans.

In addition to taking this action, we also are continuing to encourage the international community to press Cuba on human rights and demand that the regime stop harassing and detaining peaceful activists and independent journalists, release political prisoners, and provide for a democratic and prosperous future for the Cuban people. We're also encouraging anyone doing business in Cuba to consider, whether intentionally or not, they're trafficking in confiscated property and therefore abetting the regime's repression.

So in sum, this is – it's clear that by this action we are ratcheting up pressure on the Cuban Government. In the days ahead we're going to continue to monitor the impact of the suspension with an exception and assess what further action may be necessary to the national interests of the United States and to expedite democracy and support efforts by the Cuban people to bring reform to their country. We'll also continue to encourage international partners to hold Cuba accountable for propping up the Maduro regime in Venezuela and press them to stop harassing and detaining peaceful activists and independent journalists.

And with that, I'll close and happy to take any questions.

MODERATOR: Okay. Now we'll move over to the questions.

OPERATOR: Ladies and gentlemen, as a reminder, please press * then 1 if you would like to ask a question.

All right. We have a question. We have a couple people in queue for a question.

MODERATOR: Okay. We'll take the first question.

OPERATOR: All right. We'll go to the line of Matthew Lee from AP. Please, go ahead.

QUESTION: Thanks. Listen, I've read through this waiver, which is very short, and I'm having a hard time figuring out exactly how – what kind of pressure this is going to put on the Cubans. And to that – to that end, how is a U.S. company or person supposed to bring an action against these people? What courts?

And secondly, are – if there are joint ventures that are on the list of restricted entities and sub-entities, will the foreign partner in the joint venture be able to be sued as well? Thank you.

SENIOR STATE DEPARTMENT OFFICIAL: Yes, thank you very much. So I'll take those three questions in order.

So in terms of the type of pressure, so, of course, this is the first time that we are implementing –that we have an exception to the waiver for Title III. It's very clear through this action that we are going to hold the Cuban regime accountable for its confiscation of properties and ensure that there is justice for U.S. claimants.

With respect to where they bring these cases, that would be to the U.S. federal courts.

And then finally, this is with a specific focus on Cuban entities and sub-entities, so as it currently stands, the intention of the Secretary's decision is for them to be the – those against whom action is taken, not those who are engaged in joint ventures, at this time.

MODERATOR: Thank you. We'll go the next question.

OPERATOR: We will now go to the line of Nick Wadhams from Bloomberg News. Please, go ahead.

QUESTION: Hi, thanks very much. Given your answer that this will not target foreign companies, can you explain a little bit how this will be anything more than a purely symbolic move?

And then second, why do you keep shortening the exemption? Routinely it was six months prior, then the most recent exemption was 45 days, and now you've gone to 30 days. Does this signal that you're not going to keep issuing this exemption? Thanks.

SENIOR STATE DEPARTMENT OFFICIAL: Thank you very much. So with respect to the timeline, the Secretary has determined that 30 days is an appropriate time span at this time, during which period we will continue to assess the impact that it has had, and also in line with those two principles, which is U.S. national interest and expediting a return to democracy.

By limiting implementation of Title III to Cuban entities and sub-entities on the CRL, as mentioned, it does not allow Title III litigation against existing third-country investors in properties on the Cuba Restricted List. However, part of the shortening period is so that we can make a determination as to how this is affecting the calculus of others, and we will use this 30-day period as we used the previous 45-day period to encourage any person who is doing business in Cuba to reconsider whether they are trafficking in confiscated property. We cannot make a judgment or prejudge what the Secretary's decision will be at the end of this 30-day period in terms of where we move from here.

MODERATOR: We'll go to the next question, please.

OPERATOR: We will now go to the line of Juan Lopez from CNN. Please, go ahead.

QUESTION: Yes, thank you for the call. So basically, what you're announcing today is that you're taking another 30 days before you notify that the measures will be implemented. So it won't be, as we thought, March 17th, 18th. It'll be way after April.

And you said not joint ventures. So who – you mentioned U.S. citizens being able to be a part of these – this process. Who can they sue if they can't sue these joint ventures when most of those entities in Cuba that operate hotels and all other – all of these type of companies are joint ventures?

SENIOR STATE DEPARTMENT OFFICIAL: Thank you very much. So to clarify, we are saying that we are restricting the implementation of Title III to Cuban entities and sub-entities on the Cuba Restricted List. If those entities are engaged in joint ventures, it doesn't mean that the entities in the joint ventures are not able to sue. It just means that – or not able to be sued. It just means that the suit itself is brought against the Cuban entities and sub-entities.

And with respect to the 30-day period, this basically says beginning on March – the Secretary's decision indicates that beginning on March 19th U.S. claimants can begin bringing those suits against Cuban and – Cuban entities and Cuban sub-entities in U.S. federal courts. And then during that 30-day period – following that 30-day period, we will monitor the impact of that suspension and assess whether a further suspension is necessary to the interests of the United States.

MODERATOR: Thank you. We'll go to the next question.

OPERATOR: Our next question comes from Beatriz Pascual from EFE. Please, go ahead.

QUESTION: Hi. I was wondering if you have talked with your European partners about this, and what is their opinion on the matter, if there has been a dialogue. And some entities – so the measure only affects Cuban entities, but I was wondering if it could affect also entities associated with those Cuban entities. Like, if you could develop a little bit on that, that would be helpful. Thank you.

SENIOR STATE DEPARTMENT OFFICIAL: Thank you very much for that question. So in terms of our allies in the EU, Canada, and elsewhere, obviously we have engaged with them. We've consulted with our international partners and have taken those into consideration. The Secretary was very clear that part of their concerns were a factor in

his decision-making process. It is part of, of course, the U.S. national interest to assess where our partners are on this issue. We also are continuing to engage them going forward to explain this policy and to make sure that they are in the loop with respect to any future decisions that come under Title III.

With respect to the second question, you're correct. This is only allowing action against Cuban entities and Cuban sub-entities on the CRL, and it is not intended to affect European companies that are currently doing business in Cuba.

MODERATOR: Thank you. We'll go to the next question.

OPERATOR: Now go to the line of Karen DeYoung from *Washington Post*. Please, go ahead.

QUESTION: Yes, hello. I just have a couple questions. One, to – again, sorry to be so dense, but to clarify on this joint venture thing. You said if there are joint ventures, it doesn't mean that the entities in the joint ventures are not able to be sued; it just means the suit itself is brought against the Cuban entities and sub-entities. I'm just not quite clear what that means.

And secondly, there have been some people, some claimants who have already been certified by U.S. courts as eligible to sue if and when this provision was lifted. Can you clarify that a little bit, tell me how many there are, and also if and when Cuban Americans who are now U.S. citizens will be eligible?

SENIOR STATE DEPARTMENT OFFICIAL: Thanks very much for that question. So with respect to certification, this is not limited – this decision is not limited only to certified claims, and so you may be aware that there's a 1996 assessment by the State Department on how many certified and uncertified claims were out there, and so that had estimated approximately 75,000 to 200,000 potential claims that could be at play here. Of course, because we have restricted this exclusively to the Cuban entities and sub-entities on the Cuba Restricted List, that affects the final determination of how many claims are out there.

Again, on the question of joint ventures, you can – the shortest way of putting it is that you can sue the Cuban entity or the Cuban sub-entity. This action does not authorize the suit of a European, a Japanese, any other company from other countries. It's only action brought against a Cuban entity or the Cuban sub-entity on a property on the Cuba Restricted List.

MODERATOR: Go to the next question, please.

OPERATOR: We will now go to the line of Christina Smith from Voice of America. Please, go ahead.

QUESTION: Hello. Thank you. I was wondering if this measure or this decision from Secretary Pompeo was made on the basis of what's going on in Venezuela. Is this to put pressure on the Maduro government?

SENIOR STATE DEPARTMENT OFFICIAL: Thanks for that question. So the determination by the Secretary was made based off an analysis of the two statutory requirements in the LIBERTAD Act, the first of which being it – waivers only authorized in the case of a U.S. national interest as well as whether a waiver allows for an expedited transition to democracy. Those were the factors that the Secretary took under consideration.

MODERATOR: Thank you. We'll go to the next question.

OPERATOR: Michele Keleman from NPR. Please, go ahead.

QUESTION: (Inaudible) of the 200,000 potential claims, are you expecting any actual lawsuits coming out of this more restricted version of Title III, any percentage of that up to 200,000? And then secondly, the – have – has this administration had any discussions with Cuba about claims and compensations? The foreign ministry has said that they are open to such a dialogue.

SENIOR STATE DEPARTMENT OFFICIAL: Thanks very much for that question. So with respect to your first one, it's hard to say the exact number of lawsuits. This would be dependent on private action, so we can't speculate on that. And with respect to your second question, not under this current administration.

MODERATOR: Thank you. We'll go to the next question, please.

OPERATOR: We will now go to the line of Kylie Atwood, CBS. Please, go ahead.

QUESTION: Yeah, hi, thanks for doing this. Quick question: Could you just clarify what you said at the top about Cuban military intelligence and security forces and exactly how that plays into this? I was just a little confused. Thank you.

SENIOR STATE DEPARTMENT OFFICIAL: Sure, no problem. So the mention of those entities is because those are the entities on the – basically, the Cuba Restricted List identifies entities and sub-entities under the control of those authorities, so the military intelligence and security services. And so because we are – we have an exemption to the waiver for those Cuban entities and sub-entities on the Cuba Restricted List, that's why we mentioned the Cuban military and intelligence and security forces.

MODERATOR: Thank you. We'll go to the next question.

OPERATOR: Our next question comes from Andrew O'Reilly from Fox News. Please, go ahead.

QUESTION: Yeah, thanks for taking the call. I just – just wondering – following up on some of my colleagues have said about the kind of role that this will play when brought to the courts or when U.S. citizens or former Cuban citizens bring these suits to federal courts. It seems – and correct me if I'm wrong here, but it seems like it would be a symbolic thing more than anything legally binding to Cuba. Can you just kind of describe kind of what the process would be and what the government hopes to get out of this?

SENIOR STATE DEPARTMENT OFFICIAL: Sure, thanks very much. So the importance of this action and the historic nature of it is because this is the first time that we are not fully suspending the ability to bring suits. So as you're aware, the Cuban Government stole property from thousands of private citizens and businesses, and this action for the first time is holding the Cuban Government and especially, as mentioned, these forces – security forces, intelligence and military forces – accountable. It's finally giving claimants a measure of recourse and the opportunity to bring suits against these entities.

MODERATOR: All right, thank you. We have time for one last question.

OPERATOR: All right. We will go to the line of Karen DeYoung with *Washington Post*. Please, go ahead.

QUESTION: Hi. Sorry, it's me again. I just – the question I asked about whether this applies only to people who were U.S. citizens at the time of the confiscation or also to Cubans who were Cuban citizens at the time but are now U.S. citizens.

SENIOR STATE DEPARTMENT OFFICIAL: Thank you very much. Yes, it applies to all of the above. It is not just restricted to those who were U.S. citizens at the time.

MODERATOR: Thank you. Thank you, everyone, for joining us today. The embargo on this call is now lifted. As a reminder, the attribution is on background to a senior State Department official. Thanks, everyone. Have an enjoyable afternoon.


